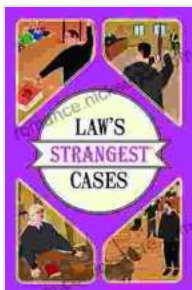


# Top 10 Strangest and Most Bizarre Legal Cases of All Time

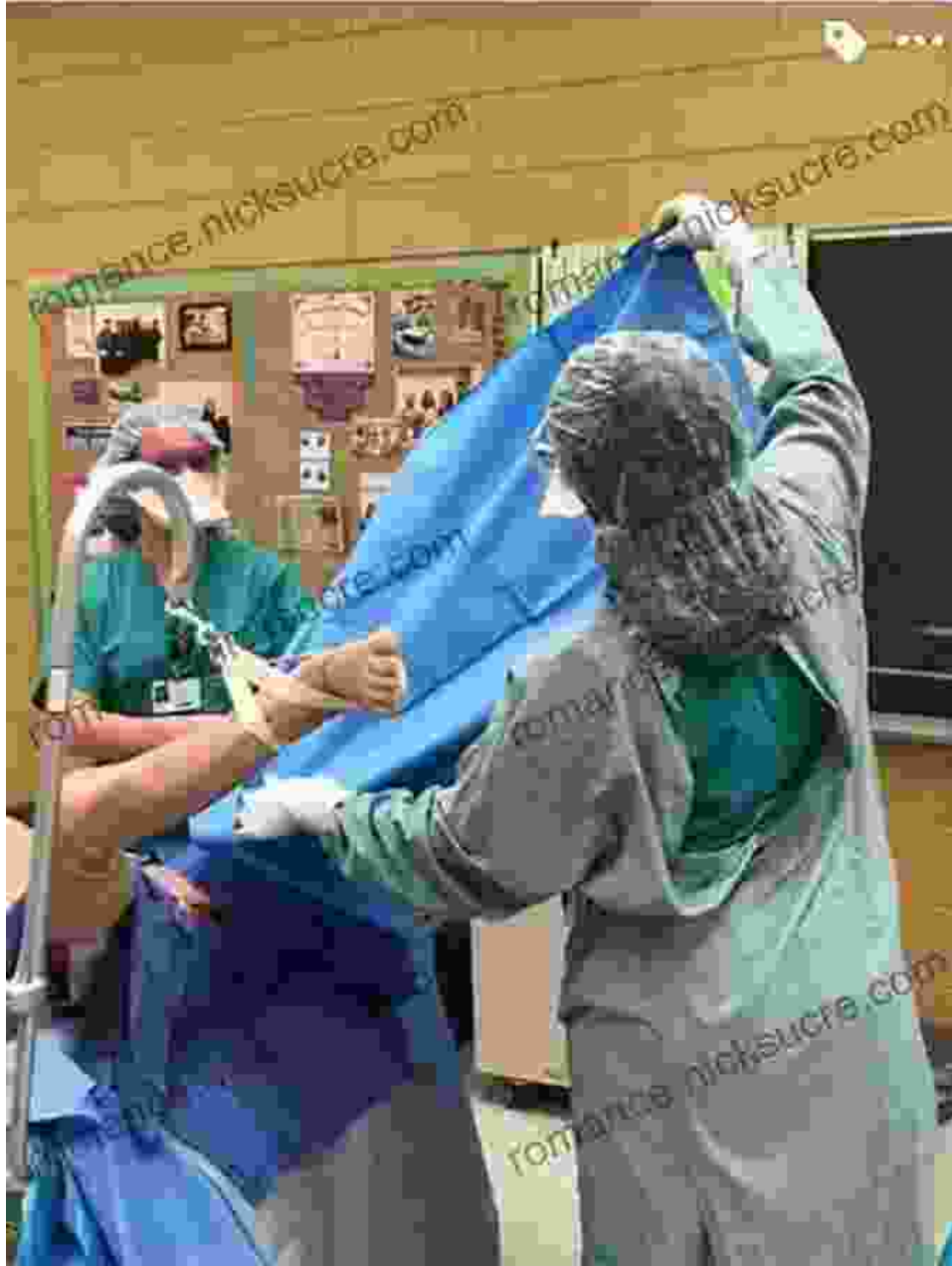
### **3. The Man Who Sued McDonald's for Not Putting Enough Cheese on His Burger**

## **7. The Man Who Sued His Wife for Cheating on Him with a Ghost**

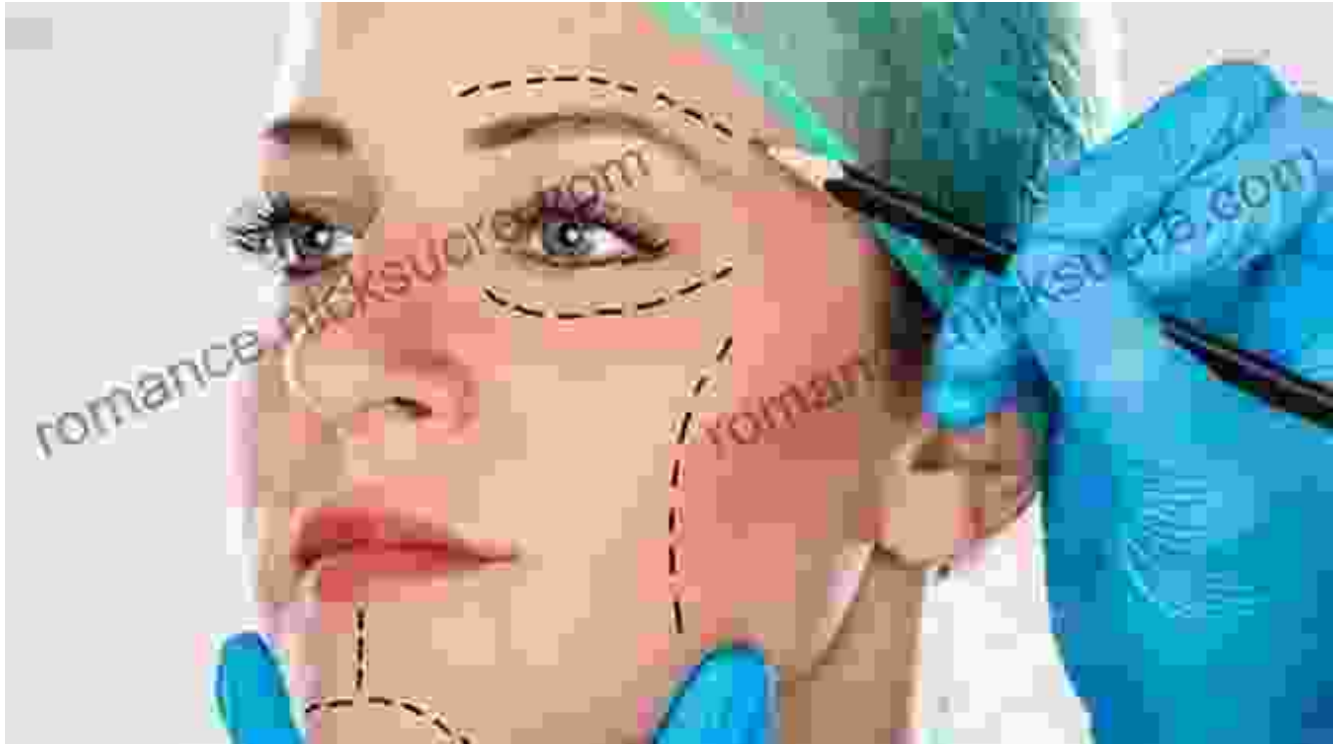

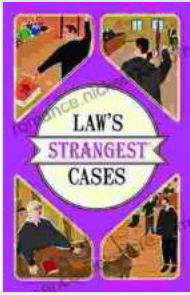


## **10. The Woman Who Sued Her Neighbors for Playing Bagpipes**

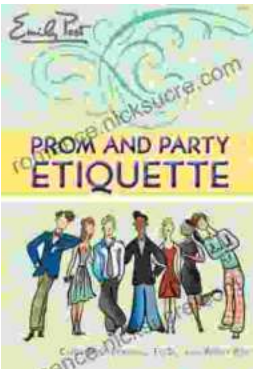

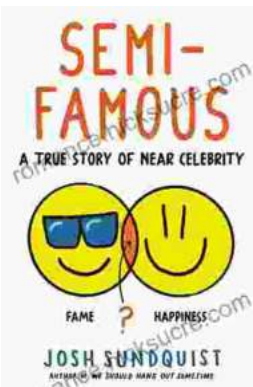
